Rental Conditions

In consideration of the Customer paying to Canadian Health Care Products Ltd. (CHCP) the Rent for the Term of this Agreement, CHCP agrees to rent the Customer the Equipment defined herein, with the Equipment to be used at the location defined herein and no others.

Title and Ownership

The title, ownership, right of property and right of possession to the Equipment shall at all times remain in and be vested in CHCP and shall not be reason of being upon or attached to any land or building whatsoever become or be a fixture or part of an appurtenant to any realty, and shall at all times be severable there from and shall be and remain at all times the property of Canadian Health Care Products, free of any claim by the Customer and every other person or corporation whatsoever. The Customer shall immediately notify the landlord or proprietor of the premises in which the Equipment is located by the Customer that the same is the property of CHCP, and not subject to any lien for any rent due or to become due by the Customer for the premises. The Customer shall give CHCP immediate notice in case of any Equipment is levied upon, or for any cause becomes liable to seizure.

Transportation

The Rent for the Equipment is F.O.B. CHCP premises, and any expense incurred by CHCP in transportation, loading or unloading at the time of delivery or of return by the Customer will be charged separately to the Customer and shall be due and payable forthwith. The Customer shall pay all shipping expenses from the original point of shipment to his receiving point and all return shipment expenses to CHCP premises, or such other point as CHCP shall, in writing, direct.

Recalling and Returning Equipment

CHCP reserves the right to remove the Equipment at any time when, in CHCP's opinion, the Equipment is in danger because of vandalism, or any other hazardous condition.

Damage to Equipment

The Customer shall be liable to CHCP for all loss or damage to the Equipment while it is in the possession of the Customer.

Inspection

Before the Equipment is loaded for transit to the Customer, the Customer may require an inspection thereof. If the Customer does not inspect the said Equipment before it is loaded for transit, then the Customer is conclusively deemed to have accepted that the Equipment is in good working order, without broken or worn out parts and in a clean and unmarred condition. CHCP shall have the right, at any time and from time to time, to enter the premises occupied by the Equipment and shall be given free access thereto and afforded the necessary facilities for the purposes of inspection.

Maintenance, Operation and Repairs

The Customer shall use the Equipment for the purpose for which it is intended only and operation in accordance with the manufacturer's instructions, and shall exert reasonable caution at all times. The Customer shall not remove, alter, disfigure or cover up any numbering, lettering or insignia displayed upon the Equipment and shall see that the Equipment is not subject to careless or needlessly rough usage. The Customer shall, at its own expense, maintain and keep in good repair the Equipment rented.

Condition of Returned Equipment

The Equipment shall be returned to CHCP by the Customer and in good repair, clean and unmarred and in good operating condition and in substantially the same condition as when received, ordinary wear and tear accepted, and if otherwise, the Customer shall pay CHCP for all labour and material for cleaning and/or repairing, to return the Equipment to that condition, and these charges shall be due and payable forthwith.

Removal from Jurisdiction

The Customer shall not remove the Equipment from the Province in which CHCP operates its premises and from which the Equipment was shipped to the Customer, without the express consent of CHCP in writing.

No Subletting

The Equipment shall not be sublet by the Customer, nor shall it assign or transfer any interest in the Agreement, without the consent in writing of CHCP.

Legal Expenses

The Customer will pay all costs, charges and expense, including reasonable legal fees incurred in retaking possession of the Equipment hereby rented, or in the collection of any sums which may be due and owing to CHCP by the Customer, including the defense of any action brought against CHCP for damages caused by CHCP Equipment to any person while such Equipment is in the possession of the Customer. The said Equipment shall be deemed to be in the possession of the Customer for all purposes of this Agreement from the time it is loaded for transit to the Customer until time that the said Equipment has been returned by the Customer to CHCP, or such other place as CHCP shall in writing direct.

Termination of Agreement

Should the Customer fall in arrears in making payment in accordance with the terms of this Agreement, or become bankrupt, or make an assignment or fail to maintain and/or operate or to return the Equipment, as provided in this Agreement, or substantially violate any provision thereof, CHCP may after three (3) days notice in writing thereof, take possession of the Equipment wherever it may be found, without becoming liable for damage for trespass or recover all rental due, together with any damages for injury and repair to the Equipment and all expenses incurred in returning and reposing the Equipment.

Waiver

CHCP shall have power to waive any default arising hereunder upon such terms and conditions, as CHCP may deem advisable and provided however, that not act or omission of CHCP shall extend to or be taken in any manner whatsoever to effect any subsequent default of the rights resulting therefrom.

Personal Injuries

CHCP shall not be liable for any personal injuries or other damage sustained by the Customer or other persons and/or for his or their property by reason of the condition or use of the machine or equipment and the Customer agrees to indemnify and safe harmless CHCP free and harmless from an such loss or damage however sustained.

Entire Agreement

This Agreement covers the entire contract between the parties hereto and CHCP shall not be responsible or liable in any way for or in respect of any undertaking, representation or warranty of any kind whatsoever leading up to or in respect of this Agreement or the Equipment given orally or otherwise which is not set out herein and the Customer agrees accordingly and without limitation to the foregoing.
